## MINUTES OF THE SPECIAL STATE LEVEL BANKERS' COMMITTEE MEETING WITH SPECIAL FOCUS ON FINANCIAL INCLUSION FOR THE STATE OF ARUNACHAL PRADESH FOR THE QUARTER ENDED DECEMBER 2022 HELD ON 12.04.2023.

The State Level Bankers' Committee Meeting for the State of Arunachal Pradesh for the Quarter ended December 2022 was held on 12.04.2023 under the Chairmanship of Shri Sandeep Kumar IAS, Principal Secretary, Agriculture Production, Govt. of Arunachal Pradesh and Co-Chairmanship of Shri Aftab Ahmad Mallick, Dy. General Manager, State Bank of India, Administrative Office, Dibrugarh at the Dorjee Khandu State Convention Centre, Itanagar, Arunachal Pradesh.

The following dignitaries also participated in the meeting: -

- (1) Shri Bidol Tayeng, IAS Commissioner, Agriculture, Govt. of Arunachal Pradesh
- (2) Shri Amarnath Talwade, IAS, Secretary RD&PR, Govt. of Arunachal Pradesh
- (3) Shri Surender Singh, Dy. Secretary, DFS, Ministry of Finance, Govt. of India
- (4) Shri Khai Siamlal Guite, Dy. General Manager, NABARD, Itanagar
- (5) Shri Pranab Pegu, AGM, RBI, Guwahati

The meeting started with a welcome speech by Shri Aftab Ahmad Mallick, Dy. General Manager, B&O, State Bank of India, Administrative Office, Dibrugarh. While welcoming the Principal Secretary, all the Secretaries and dignitaries of the State Govt. and dignitaries from DFS, RBI, NABARD and all officials of Banks operating in the State, Shri Mallick briefly highlighted the achievements of the Banks in the State in terms of growth in deposits and Advances as well as achievements under specific Schemes of DDUSY, Street vendors, Atma Nirbhar Schemes of the Govt. of Arunachal Pradesh under Agriculture and Horticulture. He also observed that some Banks were not appropriately represented with Officials of adequate seniority despite the strict instruction given by the Chief Secretary during the SLBC meeting held on 15.12.2023.

Shri Sandeep Kumar, IAS, Principal Secretary, Agriculture Production, Govt. of Arunachal Pradesh in his opening remarks observed that

- 1. Next SLBC meeting for the month of March 2023 should be held by 15<sup>th</sup> of June 2023. (Action point: SLBC)
- 2.Apart from presenting data as usual numerically, graphic and visually appealing representation would enhance value of the achievement made by the Banks.

(Action point: SLBC)

3. Banks who are under performing and are pulling down the overall performance should be identified and their performance should be scrutinized thoroughly.

(Action point: SLBC)

- 4. The extent of Digital Financial Literacy penetration should be measured in quantifiable terms and impact analysed to enhance Financial Inclusion.
  - (Action point: SLBC & Banks)
- 5. Taking the advantage of low population in the State, we should work on saturation in all the Schemes which are being implemented in the State.

(Action point: Concerned Govt. Depts. & Banks).

6. Banks should ensure that timely credit is available to the borrowers.

#### (Action point: Banks)

7. Details of money supply by the Reserve Bank of India to the Banks in the State during the last 5 years should be provided to the Government of Arunachal Pradesh through SLBC to check the level of digital penetration.

(Action point: SLBC & RBI)

This was followed by presentation of Agenda items by Shri D.K Mahato, Regional Manager, State Bank of India, Regional Business Office, Itanagar.

The minutes of the previous SLBC meeting dated 15.12.2022 were confirmed by the House. Further, the Action Taken Report was put up for discussion and observations were made as under:

#### **AGENDA 1: ATR**

a) As per minutes of the SLBC meeting dated 15.12.2022-Member Banks/RBI/NABARD/ Cooperative banks should be represented in all future SLBC Meetings by Officials with appropriate seniority. However, it was observed that many Banks were not represented by Officials with appropriate seniority and were not in a position to submit suitable explanation when sought.

(Action point: SLBC & concerned Authority)

b) SHGs are facing difficulties in opening Bank Accounts in Tirap, Changlang and Longding districts.

(Action point: Concerned Banks).

c) A separate report on performance by Banks on the Atma Nirbhar Schemes of ANBY, ANKY, ANPY, ANPPY and ANMPY should be presented.

(Action point: SLBC)

d) The status on opening of Bank branches was reviewed and found to be as under:

e) A short presentation on how to improve the performance of banks should be made in all future meeting by member Banks on rotational basis.

(Action point: Govt. SLBC & Banks)

f) Banks are yet to receive Subsidy in respect of loans sanctioned and disbursed by the Banks under the PMFME. This was also one of the agenda items during the last SLBC meeting and no

improvement was observed. There was no representation from the Industries Dept. SLBC may take up with the Department. (Action point: SLBC

&Industries Department)

#### Agenda 2. CD ratio:

a) It was pointed out that ICICI Bank was reporting Advances figure in districts where the Bank had no presence, which was highly irregular.

(Action point: ICICI Bank/RBI)

b) Special DCC meeting should be held in districts where CD ratio is less than 40%.

(Action point: SLBC)

#### Agenda 3

- a) Banks have achieved 108.38% of the ACP 2022-23 by December 2022 by sanctioning an amount of Rs.649.01 crores as against the target of Rs.598.82 crores.
- b) The priority sector lending in the State stands at Rs.3476.91 crores i.e. at 38.71%. The SLBC requested the Reserve Bank of India, to increase the priority sector limit in respect of Housing loans as many such loans sanctioned in the State are classified in the non-priority sector.

(Action point: SLBC & RBI)

#### Agenda 4

- a) Banks have sanctioned 624 loans amounting to Rs.67.53 crores under the Deen dayal Upadhyay Swavalamban Yajana (DDUSY) since inception.
- b) Axis Banks Seppa Branch has returned all 3 DDUSY applications without assigning any reason. Representative from Axis Bank was not aware of this. LDM, Seppa was advised to re-send the applications to AXIS Bank Seppa.

(Action point: LDM Seppa)

c) RBI observed that loan applications will be returned or rejected with valid reasons.

(Action point: All Banks)

#### Agenda 5.
