MINUTES OF ASSAM STATE LEVEL BANKERS' COMMITTEE MEETING FOR JUN'23 QUARTER, HELD ON 12.10.2023, IN ASSAM ADMINISTRATIVE STAFF COLLEGE, KHANAPARA, GUWAHATI

Assam SLBC Meeting for Jun'23 quarter, was held on 12.10.2023 at Assam Administrative Staff College, Khanapara, Guwahati. The meeting was chaired by Shri Paban Kumar Borthakur, IAS, Chief Secretary, Government of Assam and co-chaired by Shri Amaresh Kumar Jha, General Manager & SLBC Convenor, Assam. The Meeting was attended by the senior officials of RBI, NABARD, SIDBI, member Banks,LDMs (virtual Mode), line departments of Government of Assam and various other agencies. The following notable dignitaries attended the meeting:

- 3. Dr. Ravi Kota, IAS, Addl. Chief Secretary, Home, Industries, Commerce & Public Enterprises Department, Government of Assam
- 4. Shri Samir Sinha, IAS, Addl. Chief Secretary, Finance, Government of Assam
- 5. Shri Jayant Narlikar, IAS, Commissioner & Secretary, Finance, Government of Assam
- 6. Smt. Sushmita Phukan, Regional Director, RBI Guwahati
- 7. Shri Naveen Dhingra, Chief General Manager, NABARD, Guwahati

All other officials present in the meeting is placed in "Annexure-l"

Shri Hemant Gadge, DGM, SLBC, on behalf of SLBC, welcomed all the participants of the SLBC meeting.

Shri Amaresh Kumar Jha, General Manager & SLBC Convenor, extended warm greetings to all the participants and welcomed Tamilnad Mercantile Bank Ltd in SLBC Assam. He delivered a comprehensive review of major areas of financial activities of the banking system in Assam. He exhorted all Banks to focus on ensuring target achievement under ACP for the current FY 2023-24. He drew the attention of the house towards the growing NPAs in PMEGP scheme and expressed his concern for the same. He also asked Member Banks showing NIL figures in GSS to come out of NIL zone. He briefed the house about launch of new flagship schemes like GHAR GHAR KCC, Jan Suraksha Abhiyan at Gram panchayat level and PM Vishwakarma Scheme and asked support from all member Banks in making these schemes successful. Shri Gyanendra Pratap Singh, IPS, Director General of Police, Assam, spoke on Cyber Crime and related hazards. He raised his concerns about delay in refunding money to customers in case of erroneous transactions. He further raised alarms about non availability of CCTV cameras in ATMs. He suggested that for safety purpose ATMs could be opened near police stations. He also raised the issue of money mule accounts and asked member Banks to ensure that there is no connivance on the part of the Bankers. He exhorted all member Banks to disburse loans to surrendered militants while appreciating the efforts of SBI towards the same.

(Action point: SLBC, All Member Banks)

The house adopted the minutes of State Level Bankers' Committee meeting for March, 2023 quarter held on 23.06.2023.

AGENDA PRESENTATION:

Shri Joy Chandra Chakma, AGM, SLBC, Assam, presented the agenda of the meeting. Some of the notable observations made in the deliberation are given below:

CREDIT DEPOSIT RATIO:

Shri Paban Kumar Borthakur, IAS, Chief Secretary, Assam appreciated the member Banks for breaching 60% CD Ratio and asked all member Banks to aspire to achieve 80%. Banks with less than 50% CD Ratio were pointed out by the Chair and they were asked to explain the reasons for the same. On this Union Bank of India informed the house that despite doing major project finance in Assam the data was not reflected in the portal because of accounting issues. The Chair asked the Bank to resolve the issue at the earliest and improve CD Ratio. LDMs below 40% CD Ratio assured the house to achieve 50% CD Ratio by December,2023.

(Action Point: Banks below 50% CD Ratio (AU, Utkarsh, SIB, Union, CBI, APEX, YES, UCO, PSB, INDIAN, UJJIVAN, CANARA, JSF, IDBI, AGVB), LDMs of Districts below 40% CD Ratio (Karimganj, Dimahasao)

Banks with negative growth in deposit and advances were asked to furnish the reason for the same. Additional Chief Secretary, Finance showed his displeasure over Bandhan Bank for showing YoY negative growth in advances and asked action plan for improvement.

(Action Point: Canara Bank, Bandhan Bank)

ACP& PRIORITY SECTOR ADVANCES

The house was informed that 4 Banks showed 100% target achievement under ACP and discussion on their reporting method took place. DGM SLBC requested RBI to clarify the reporting methodology to remove ambiguity while reporting quarterly data.

(Action point: RBI, HDFC, ICICI, AXIS, YES Bank)

Dr. Ashish Kumar Bhutani, IAS, Addl. Chief Secretary, Agriculture, Government of Assam exhorted the house to disburse KCC to all PM Kisan beneficiaries and link all KCC accounts with Pradhan Mantri Fasal Bima Yojna. He urged the Bankers to ensure deduction under PMFBY. He also asked Banks to ensure AADHAR seeding with the Bank accounts of remaining PM Kisan beneficiaries. Banks with Priority Sector Advances in Agri less than 18% were questioned on their poor performance by Chief Secretary. CGM, NABARD exhorted SBI to push Agri advances as their performance is not at par with the number of branches operating in the state of Assam. The Chair asked banks having PSA in Agri less than 18% to improve their performance.

(Action point: Banks having PSA in Agri less than 18%: BOB, BOI, BOM, CANARA, IOB, PSB, SBI, UCO, AXIS, Bandhan, Federal, HDFC, ICICI, IDFC, IDBI, Indusind, KBL, KMB, SIB, YES, AU, Ujjivan, USFB)

Dr. Ravi Kota, IAS, Addl. Chief Secretary, Home, Industries, Commerce & Public Enterprises Department asked the house to look into the rationalization of interest rates in MSME products. He stressed upon the PM Vishwakarma scheme and informed the house that Assam has the third highest registrations under the scheme. He discussed about CM Atmanirbhar Abhiyaan and exhorted house to push the product. He also informed the house that state Government has signed 40 MoUs with various industrial houses and asked Banks to chip in with adequate financial support. Chief secretary asked Banks to lend wholehearted support in industrial finance. The lack of awareness among bankers about flagship MSME schemes of Government was taken up in the house. Discussion was held on major issues hampering the disbursements of loan under flagship schemes like PMFME and PMEGP. The Chair asked to strengthen interface between DIC and Banks to curb rejections in PMFME and PMEGP.

(Action point: All member Banks, KVIC Department, PMFME Department & Industries & Commerce Department)

GOVERNMENT SPONSORED SCHEMES (GSS):

Chief Secretary asked Banks with Nil contribution in one or more GSS to respond the reasons behind their dismal performance. Member Banks with Nil performance under the various schemes were asked to give written reply to SLBC for non-performance.

(Action point: All Nil GSS sanctioned Banks. AXIS, BAND, FED, HDFC, ICICI, IDFC, INDUS, KBL, KMB, RBL, SIB, YES, AU, ESAF, JSF, NESFB, UJJ, USFB, APEX)

Shri Samir Sinha, IAS, Addl Chief Secretary, Finance elaborated upon the initiatives taken by state Government under PMSBY and PMJJBY to enroll people under BPL category which has been extended to Safai karmacharis to ensure 100% coverage of BPL population. He underlined the need for large scale campaign under the aegis of SLBC for improving the penetration of the Social Security Schemes which is still lagging behind despite State Government support. He also informed the house about the Credit guarantee fund of the GoA for SME loans over and above the Central Government credit guarantee schemes. He informed the house that for NPA recovery, D.O. letters have been sent to all the DCs for recovery under SARFAESI and extended all support to Banks for recovery of bad loans. The Chair asked the house to prepare mechanism for analyzing the reasons behind rejected settlement claims under PMJJBY and PMSBY.

PM SVANidhi

Chief Secretary reviewed the performance under the scheme. House was informed that targeted disbursement under first tranche had been achieved by the banks. However, targets under 2nd tranche and 3rd tranche were due for achievement. Member Banks were asked to mark the repaid loans as closed in the portal to increase the number of eligible beneficiaries for 2nd tranche disbursement. Further, NULM department exhorted the member Banks to increase digital onboarding of the PM Svanidhi beneficiaries.(Action point: All Member Banks)

RSETI:

Chief Secretary asked the member banks to ensure 100% credit linkage for trainees under RSETI. The House was also informed about the constraints faced by few Banks in setting up RSETIs. State Director, RSETI sought support from all member Banks for credit linkage. He also asked Banks to increase set up their own buildings as they are not adequate as of now.

(Action point: RSETI, ASRLM,All RSETI Sponsored Banks) Aspirational Block Programme:

The House was informed about the concept of Aspirational Block Programme. It was informed that 20 blocks from 13 districts had been identified in the state as Aspirational Block Programme which were being closely monitored by the Niti Aayog and PMO. The Chair drew the attention of the House to lay special focus on these Aspirational Blocks and repeat the success they had achieved under Aspirational Districts programme. All member banks were asked to submit action plan for setting up of new branch, BC/CSP and implement Jan Suraksha Scheme in these blocks.

(Action point: All Member Banks)

DEPOSITORS EDUCATION AND AWARENESS (DEAF) FUND -<u>"100 DAYS 100 PAYS:</u>

The House was informed that under the Depositors Education and Awareness (DEA) Fund - "100 Days 100 Pays" Campaign with respect to unclaimed deposits, that commenced on June 1, 2023 and concluded on September 8, 2023, 22 banks in Assam have settled ₹36.30 crore pertaining to 1412 accounts. The banks were asked to continue settling those accounts. Reserve Bank of India launched a Centralized Web Portal UDGAM (Unclaimed Deposits-Gateway to Access information) on August 17, 2023 for the public to facilitate and make it easier for them to search their unclaimed deposits across multiple banks at one place. The search facility has been extended to 30 banks as on September 28, 2023, covering around 90% of such unclaimed deposits (in value terms) in DEAF accounts. The Chief Secretary asked RBI to divulge the details of Government accounts under DEAF scheme with the Finance Department, Government of Assam.

(Action point: RBI, All Member Banks)

Smt. Sushmita Phukhan, Regional Director, RBI stated that under the scaled-up project on Centre for Financial Literacy (CFL), 80 CFLs have been established across the state of Assam covering all the blocks. Awareness camps are being regularly conducted by the CFLs. All bankers, LDMs, DDMs and NABARD representatives are advised to keep a track of the schedule of events shared by CFL coordinator, participate in some of the camps and share their feedback with RBI for making the initiative more meaningful and effective.

(Action point: RBI, NABARD, LDMs, All member banks) <u>SETTING UP OF BRICK-AND-MORTAR BRANCHES IN</u> <u>UNBANKED VILLAGE:</u>

Bank of India had requested to approve three alternate locations within 5 kms of the originally proposed sites for opening of branches i.e.Charidur at Balipara in place of Chari Duar Forest Prtd. Area, Nonoipara at Garuajhar in place of Nonoipara T.E. and Salbari at Shantipur instead of Salbari F/Block. Similarly, SBI had requested to move the proposed site for opening of branch from Orangajuli T.E. to Dimakuchiwhich is within 5 Kms of the originally proposed site.The House approved their request and asked rest of the banks to complete the process by/before 31.12.2023.

(Action point: BOI, SBI, BOB, BOM, Canara, CBI, HDFC, ICICI, PSB, PNB, UCO, Union)

LOW ATM PENETRATION IN 13 DISTRICTS:

In Assam, there are 13 districts where ATM penetration is much below the national average. Accordingly, RBI has set a target of new ATMs to be installed in these districts. Regional Director, RBI informed the house that LDOs were discussing this matter in the respective DCC meetings. She requested the State Government to advise the Deputy Commissioners of the districts concerned to identify suitable locations for setting up of new ATMs and monitor the progress in DCC meetings. The Shortfall data in ATMs in 13 districts are as follows.

STATE INSURANCE PLAN:

In line with the vision of "Insurance for all" by 2047, Regulatory and Development Authority of India (IRDAI) is rolling out State Insurance Plan for all states along with identifying a lead insurer for each State. Shri Jayant Narlikar, IAS, Commissioner & Secretary, Finance Department gave a brief on State Insurance Plan and its importance. Also, emphasized on progress of formation of State Level Insurance Committee (SLIC) till date. The project presentation was given by the representatives of the Lead Insurers Shri Nityananda Bose , Shri Mahesh Radhakrishnan and Shri Vijay Anand.

The Chief Secretary, Assam assured that the areas of cooperation as expected by the Lead Insurers from the State Government will be taken care of. Also, he advised the Lead Insurers to come up with a concrete action plan and the expectation from the members of SLBC.

The Chair advised the Lead Insurers to drive the project in all districts at one go instead of covering only 5 districts in phase 1. He also asked to arrange a workshop among all the Insurers and Bankers and to initiate the activities with a grand launch of the project.

The Lead Insurers requested the SLBC to involve SLIC in their activities

for insurance awareness campaign. The representative from RBI also requested to all Bankers to support in the activities of SLIC.

Shri, Naveen Dhingra, CGM NABARD informed that the banks are already working in the field of Insurance Awareness. All the insurers as well as all verticals of insurance industry should work together in this area. He also added that insurers can use the available infrastructure, the Financial Literacy Centers (FLC) to drive the awareness campaigns.

The Chair summed up with following points which are to be done:

- a) Preparation of an institutional mechanism of SLIC.
- b) Preparation of an action plan.
- c) Organizing workshop among all insurers and bankers.

The lead Insurers requested to appoint a Single Point of Contact (SPOC) person from Government of Assam for SLIC. In this, the Chair verbally indicated Shri Jayant Narlikar, IAS, Commissioner & Secretary, Finance Department as the SPOC person to maintain coordination between Government of Assam and SLIC.

(Action point: Lead Insurer Company)

The meeting ended with a vote of thanks by Shri Prabhat Kumar, DGM, Union Bank of India, Assam.
