MINUTES OF ASSAM STATE LEVEL BANKERS' COMMITTEE MEETING FOR MAR'23 QUARTER, HELD ON 23.06.2023, IN ASSAM ADMINISTRATIVE STAFF COLLEGE, KHANAPARA, GUWAHATI

Assam SLBC Meeting for Mar'23 quarter, was held on 23.06.2023 at Assam Administrative Staff College, Khanapara, Guwahati. The meeting was chaired by Shri Paban Kumar Borthakur, IAS, Chief Secretary, Govt. of Assam and co-chaired by Shri Vincent M.D., CGM, SBI. The Meeting was attended by the senior officials of RBI, NABARD, SIDBI, member Banks, Deputy Commissioner of Aspirational Districts (Virtual Mode), line departments of Government of Assam and representatives of other agencies. The following notable dignitaries attended the meeting:

- 4. Smt. Sushmita Phukan, Chief General Manager, RBI Guwahati
- 5. Shri Naveen Dhingra, Chief General Manager, NABARD, Guwahati
- 6. Smt. Suranjana Dutta, General Manager, SBI & SLBC Convenor

All other officials present in the meeting is placed in "Annexure-I"

Shri Hemant Gadge, DGM, SLBC, on behalf of SLBC, welcomed all the participants of the SLBC meeting.

Shri Vincent M.D., CGM, SBI and SLBC Convenor, welcomed and extended warm greetings to all the participants. He delivered a comprehensive review of major areas of financial activities of the banking system in Assam. Hespoke in detail elaborating upon the level of resilience & strength of banking infrastructure in the State of Assam and the progress made by the banks in parameters like CD Ratio, Annual Credit Plan (ACP), Priority Sector Advances, MUDRA, PMEGP and the progress made under PM SVANidhi, KCC Saturation drive

under animal husbandry, fisheries, and Social Security Schemes. However, he expressed his concern about NPA level in PMEGP and PMSVANidhi. He urged all member banks and LDMs to push Jan Suraksha Campaign as it has been extended by 1 month i.e.upto 31.07.2023. He also advised the house about the 14 low priority sector lending districts and request them to avail the benefits of 125% credit weightage for these 14 districts RBI's Circular dated September 04, 2020.

Shri Naveen Dhingra, CGM, NABARD, applauded the Bankers for improvement inCD Ratio in the State during the last Financial Year. He expressed his concern onunder achievement of Banks in Crop Loan disbursement. He stressed upon the need of driving Agriculture Credit Sector through credit support to small tea growers and temporary workers employed with large tea growers. He informed the house that 18 districts of Assam state had been identified under Oil Farm Mission scheme of Govt. of India and urged the Banks to lend their support to make the scheme a success.

Smt. Sushmita Phukan, CGM, RBI, also lauded the bankers for putting up a good show towards improvement of CD Ratio. She informed the House about the campaign launched for claiming of unclaimed deposits "100 days 100 pays" and asked Banks to drive the initiative. She expressed concern about the low ATM penetration in 13 districts of the state and asked LDMs to oversee the performance in DCC meetings and submit report to SLBC.

(Action Point: All LDMs)

Dr. Ashish Kumar Bhutani, IAS, Addl. Chief Secretary, Agriculture, Govt. of Assam, in his opening remarks, expressed concern regarding under performance of Crop Loans and allied activities despite the target being low. He urged the Banks to drive PM KISAN Scheme by extending loans to beneficiaries under the scheme. He also urged the Banks to complete Aadhar seeding in all eligible PM Kisan Beneficiaries by 30.06.2023 so that all eligible beneficiaries in time to receive the benefit. He further asked member Banks to increase PMFBY coverage. He asked Banks to promote Agri Infrastructure Fund (AIF) scheme and convert all eligible AIF proposals.

(Action Point: All Banks)

Shri Paban Kumar Borthakur, IAS, Chief Secretary, Govt. of Assam, wasappreciative of improved CD Ratio but he sought further improvement especially in Low performing districts and Banks.He called for contribution from every member Bank in achievement of targets under ACP and GSS. He expressed concerns on the huge number of rejections of priority sector advances.

AGENDA PRESENTATION:

Shri Joy Chandra Chakma, AGM, SLBC, Assam, presented the agenda of the meeting. Some of the notable observations made in the deliberation are given below:

CREDIT DEPOSIT RATIO:

Chief Secretary asked for responses and strategies for improvement from the banks and LDMs of the districts with CD Ratio less than 50% for achieving the National Benchmark and report to SLBC. LDM, Karimganj assured to achieve 40% CD Ratio by September'23 and 60% by March'24. Further, Chief Secretary asked the Branch Mangers of 5 low performing branches about the reasons and difficulties faced by them and the way forward. The branches were asked to develop strategies for shoring up credit growth and achieve CD Ratio of 60% by year end.

(Action Point: Banks below 50% CD Ratio (Canara Bank, Indian Bank, IDBI, RBL CBI, PNB, PSB, UCO, Union, SIB, Ujjivan, AGVB, KMB, AU, JSF, Utkarsh, Apex), LDMs of Districts below 40% CD Ratio (Karimganj, Dimahasao)

ACP& PRIORITY SECTOR ADVANCES

The house was informed that all banks hadachieved 127% of ACP Target during FY 2022-23. Chief Secretary, Govt. of Assam asked the strategies for achievement of targets from the underperforming banks. Chairman, AGVB raised the issue of disproportionate target allocation to the branches as compared to their scale. Chief Secretary was informed that ACP Target was distributed by the LDMs among the Banks after due consultation with the banks in DCC meeting. Principal Secretary, Finance suggested to convene a special DLCC meeting to redress the issue of disproportionate allocation of targets under ACP.

(Action point: All LDMs, Utkarsh, Apex Cooperative, Ujjivan, ESAF, Punjab & Sind Bank, IOB, BOI, AGVB, IDBI, JSF, BOB, CBI, IDFC, BOM)

Principal Secretary, Finance emphasized on strengthening the mechanism for implementation of ACP especially with regard to MSME. He informed the house that the Govt of Assam wanted Bankers to especially focus on Micro and small enterprises. Mukhya Mantri Sva-Niyojan Mission launched by the Govt of Assam for creating employment in MSME sector was discussed in the meeting. Commissioner, Industries & Commerce Dept. highlighted that the loans are mostly disbursed in the later part of the FY 2022-23 and higher proportion is of term loans as compared to Working Capital Loans.

Chief Secretary, Govt. of Assamwanted to know the reason behind the gap from the concerned Department. Principal Secretary, Finance raised the issue of abysmally small ticket size of loans under priority sector in the state of Assam. He requested the Chief Secretary, Govt. of Assamfor formation of a sub-committee on MSME. The house was informed about three new schemes launched by Govt of Assam for MSMEs which are Mukhya Mantrir Laghu Udyog Udagoni Aachoni, Chief Minister's MSME Interest Subvention Scheme and Assam Credit Guarantee to Micro & Small Enterprises Scheme. The Commissioner, Industries & Commerce Dept. requested for waiver of CIBIL scores for small ticket loans. CGM SBI informed that Banks are relaxing CIBIL requirement in Settled Credit Card dispute cases.

(Action point: Industries & Commerce Department, Govt. of Assam)

The ACP Target for FY 2023-24 were approved in the house for onward circulation among the member Banks and stakes holders.

(Action point: SLBC, All Member Banks)

GOVERNMENT SPONSORED SCHEMES (GSS):

Chief Secretary took serious note of non-financing in Govt. Sponsored Schemes by Banks in the State and urged them to improve their performance in this fiscal. CGM, SBI suggested house not to reward such Banks with deposits who are not doing GSS.

(Action point: All Nil GSS sanctioned Banks. AXIS, BAND, FED, HDFC, ICICI, IDFC, INDUS, KBL, KMB, RBL, SIB, YES, AU, ESAF, ISF, NESFB, UJJ, USFB, APEX)

PMFME

The Industries and Commerce Department raised the issue of high rejection ratio of PMFME proposals in Assam. Chief Secretary asked the Department to involve the DCs to follow up the cases in DCC meetings. CGM, SBI suggested that the PMFME proposals should be distributed in proportion to the density of the branches in a particular area. He pointed out that a proper tracking mechanism could be developed to monitor the fate of the proposals.

(Action point: Industries and Commerce Department, Govt. of Assam, All Member Bank)

The Targets for FY 2023-24 under NRLM, NULM, PMFME & PMEGP were approved in the house for onward circulation among the member Banks and stakes holders.

(Action Point: SLBC)

PM SVANidhi

CGM SBI requested house to ensure maximum disbursement. Further, he asked the House for proportionate allocation of targets.

(Action point: PMSVANidhi Department, Govt. of Assam, All Member Banks)

RSETI:

House was informed that SLBC conducted a sub-committee meeting on 17.05.2023 in which status of all 7 banks had been discussed for performance and progress of setting up of new RSETIs. Official from ASRLM Department informed that money from MoRD had been received and reimbursements of all pending bills are on course. State Director, RSETI raised his concerns on RSETI Infrastructure, Reimbursement of training cost to Banks and Credit Linkage for RSETI Candidates. All RSETI buildings need to be completed by 31.12.2023 as per MoRD. He informed that Reimbursement of training cost will be completed soon. He further informed the House that Credit linkage support of 70% and settlement of 100% has been set as the new benchmark by MoRD. Chief Secretary enquired about the monitoring mechanism of the quality of training.

(Action point: RSETI, ASRLM, All RSETI Sponsored Banks)

100% DIGITIZATION OF MAJULI DISTRICT AND IDENTIFICATION OF DIGITAL DISTRICT FOR 3rd PHASE:

Under performing Banks were asked to achieve 100% digitization by 31.07.2023.

Charaideo district was identified as the new Digital District in the SLBC Sub-committee meeting on 02.06.2023. Punjab National Bank is the lead bank for Charaideo district. The house approved that PNB would be Nodal Bank for newly identified Digital District Charaideo. Further, it was decided that allbanks would have to complete the task of 100% digitization by 31.12.2024.

(Action point: Canara, PNB, AGVB, All Banks operating in Charaideo District)

ASPIRATIONAL DISTRICTS' (ADs) & MISSION UTKARSH DISTRICT

Chief Secretary reviewed the work done by LDMs in the aspirational districts. CGM SBI asked SLBC to prepare data of achievement of targets by the Banks under various parameters in the Aspirational Districts. He informed about the concept of Aspirational Blocks in the state of Assam similar to erstwhile Aspirational Districts and asked Bankers to provide satisfactory credit support to the selected blocks.

(Action point: SLBC, LDMs of Aspirational Districts and Mission Utkarsh District)

FINANCIAL INCLUSION MEASURES IN TEA ESTATES OF ASSAM

CGM, SBI informed that the desired support from the Tea Garden management is not encouraging in terms of infrastructure like space and power connection. He suggested that an alternative could be deployment of mobile ATMs. Chief Secretary urged the house to streamline the issues with joint effort and assured all support from Govt of Assam.

(Action point: PNB, UCO, SBI, INDIAN, BOB, ICICI, CBI, UNION)

PM-KISAN

Principal Secretary, Govt. of Assam informed the house that so far 9.5 lakh beneficiary accounts had been linked to AADHAR. Additional 1.5 Lakhs accounts was decided to be linked with Aadhar by 30.06.2023. The list of beneficiaries was already available with DCs and LDMs were asked to distribute the same among the various Banks for expediting the Aadhar linkage of beneficiary accounts.

(Action point: All Member Banks)

PRADHAN MANTRI FASAL BIMA YOJNA

CGM, SBI urged all member banks to focus on the product and to handhold the customers to avail the benefit of the scheme.

(Action point: All Member Banks)

UNBANKED VILLAGE ALLOCATION

SLBC requested the house to exclude villages with a population of less than 100 people. AGVB flagged their concern in front of the house regarding the economic unviability of the CSPs because of lower transactions in these scantily populated villages. The house was requested to approve deletion of those villages from the list so that the same may be conveyed to DFS for implementation. Chief Secretary was of the view that the matter needed further analysis and deliberation.

(Action point: SLBC)

The meeting ended with a vote of thanks by the AGM, SLBC, Assam.
